

## **South Australia Business Migration Options** Business Innovation Stream (subclass 188/888)

The Business Innovation Stream is available for people with business skills who want to establish, develop and manage a new or existing business in South Australia. This visa is for high net worth business owners with ownership in a business or businesses with a turnover of at least \$AUD500,000 and combined net business and personal assets of at least \$AUD800,000.

## Applicants intending to apply for state nomination in South Australia should note the following:

- Clients must have undertaken a physical exploratory visit to South Australia before applying for State nomination.
- > The primary applicant must undertake the business and reside in South Australia while on the 188 visa.
- The applicant must meet one of the benefit to state requirement as defined below depending on age and business location.

2. Values for export refer to purchase value

3. A regional business is defined as a business located in an area outside of metropolitan Adelaide. Applicants must be living and conducting business in regional South Australia. **Visit www.migration.sa.gov.au for a list of regional areas**.

- 4. Full Time Equivalent (FTE) employees refers to employees under the direct employ of the business working a minimum of 30 hours per week paid at least the award wage. Employment for each FTE required is for a minimum of 12 months within 24 months of the 188 visa business management period.
- 5. FTEs must be Australian citizens, permanent residents, or New Zealand passport holders. Family members are not eligible to be included in the FTE requirement.
